a. City Survey Results

Chief Swing presented the survey results. Committee members discussed ways that the City and School District can continue to actively partner with each other and community groups in support of youth and safe schools. School Resource Officers make a positive difference for students, but additional officers would be helpful. Dr. Smith commended the officers who volunteer their time with students in the sports mentoring program. The City is in the process of polling the community to gauge support of a parcel tax extension for the library, which benefits students, schools and the entire community.

b. Review future meeting dates

- Thursday morning meetings present a scheduling conflict for MHPD personnel. Committee members want MHPD to be represented. City will suggest some days of the week that would work better.*
- c. Corporation Yard Update
District has an interest in owning a Corporation Yard. City has an interest in expanding Community Park. City staff will research the initial land purchase to see if there are any restrictions.
 - d. General Plan Update Process
The City is embarking on a 2-3 year process for updating the General Plan. They have hired a consultant and formed a 17-member community advisory committee. The first meeting is scheduled for February 28. They have launched an informational website, www.morganhill2035.org, and will use web-based “Open Town Hall” as an online forum for the community.
 - e. Annual Joint Meeting Date
District and City staff will look for a date in late April / early May for a joint meeting. The Board of Education will consider a special meeting or a portion of an already scheduled meeting for a school safety presentation and invite City and Police Department representatives.
 - f. Other
*Mayor Tate thanked Dr. Smith for his major contributions on the RDA Oversight Committee.
District is developing a proposal to reopen Burnett School and expand the Central Continuation High School program to accommodate more students, as well as provide other services not currently available to youth in the community. The remodeled school will also be used as a prototype for classroom technology throughout the district.*

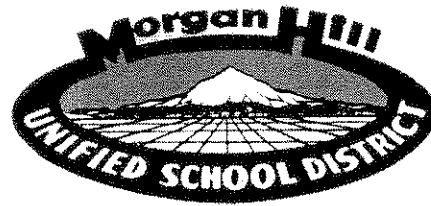

BEST PRACTICES FOR CITIES' SUPPORT OF INNOVATIVE, HIGH-PERFORMING SCHOOLS

1. Collaborate and work with school districts to address issues of common concern to our parents and kids. Examples of valuable collaboration include:
 - a. Partnerships to expand recreational opportunities, such as through joint use agreements on parks, playgrounds, swimming pools, camps, facilities, and afterschool/summer programs;
 - b. Supporting, facilitating, and advocating corporate, foundation, and college partnerships with local schools/districts to supplement educational and social programs. Partnerships can take the form of financial support, a commitment of volunteers, and (for colleges) service-learning programs.
 - E.g., Sunnyvale's collaboration with Advanced Micro Devices at the Columbia Neighborhood Center
 - c. Supporting school safety, by sharing funding of crossing guard programs and public safety neighborhood resource officers at each school.
 - d. Coordinating library programs, services, and hours to address the needs expressed by local school teachers, principals, and parents.
 - e. Engaging in school related ballot measures, and encouraging individual councilmembers to take an active role with those measures.
 - f. Facilitating and encouraging collaboration among multiple organizations—incorporating educational, criminal justice, police, health, faith-based, and other groups--to identify and confront the challenges that youth face in the influences of gang, drugs, pregnancy, bullying, depression, and other risks.
 - E.g., Sunnyvale's Challenge Team; the San Jose Mayor's Gang Prevention Task Force.
 - g. Making active communication with school districts and principals an institutional habit, by:
 - 1) Ensuring district and school officials have ample notice of pending municipal decision-making that could impact schools and children, particularly regarding housing and land use.



- 2) Designating a liaison or council subcommittee who will attend at least one district board meeting, and act as the point of contact for district communications with the Council.
2. In consultation with the local school district(s), commit to a set of clearly defined, specific measures for closing the achievement gap within the city, and for establishing a “no excuses” environment for reaching those goals.
 - E.g., the SJ/SV 2020 Plan
 3. Assist in the replication of proven, high-performing school models—whether public “small schools,” charter public schools, or other schools that do not charge tuition—by enabling efforts to get school facilities up and running by:
 - a. Streamlining land use approvals for new school sites through fast-tracked zoning approvals, within the objectives of each city’s general plan;
 - b. Exploring assistance to schools in financing new or renovated facilities, such as by approving conduit financing for bonds issued by the California Statewide Communities Development Authority, or by guaranteeing publicly issued bonds during school startups;
 - c. Encouraging access to city-owned facilities and land by schools through joint-use agreements.

- A) Developmental Assets update
Many efforts are occurring throughout the community that support the developmental assets. These include MHUSD, Youth Action Council, newly formed faith-based group Community Asset Builders (Youth Collaborative). It was decided that developmental asset building efforts would be the focus of the annual joint city council/school board meeting on June 14.
- B) MHUSD General Obligation Bond update
Polling came back relatively positive. A general obligation bond may be pursued for facility repair/upgrades and some program improvements. To date, there has not been any action by the Board. The District is currently creating a list of priorities for Board consideration with a decision expected in May. The district may also dedicate some of the

bond money to technology and potential magnet school(s).

- C) Redevelopment Agency update
RDAs throughout the state were dissolved on February 1, 2012. There is no new tax increment revenue. The City can make claims to meet existing recognized obligation payment schedule (EROPS). The oversight board has been formed. In general, as the former RDA's obligations decrease, other taxing agencies' revenues increase. The "pass throughs" will continue in any event.
- D) Other
The City has assigned an interim Student Resource Officer (SRO). The Sierra LaMar case is being handled by the Sheriff's Office. Committee members agreed to cancel the next Liaison Committee meeting (June 21) due to the June 14 joint meeting.
