

**MORGAN HILL UNIFIED SCHOOL DISTRICT
ADVERTISEMENT AND NOTIFICATION FOR PREQUALIFICATION
Extension Due February 24, 2017**

Notice is hereby given that the Morgan Hill Unified School District (“District”) has determined that contractors on future projects must be prequalified prior to submitting a bid or proposal on a project. California Assembly Bill (AB) 1565 went into effect on January 1, 2014. AB 1565 requires ALL General Contractors and M/E/P Subcontractors to be prequalified, if the contract is valued at \$1 million or more and funded whole or in part with State Facility Bond funds.

It is mandatory that all contractors, who intend to submit a bid or proposal, fully complete the District’s prequalification questionnaire, provide all materials requested therein, and be approved by the District to be on the final qualified Contractors list. **(THE DISTRICT WILL BE ACCEPTING PREQUALIFICATION APPLICATIONS ON AN ANNUAL BASIS.)**

It is mandatory that all of the following contractors who intend to submit a bid or proposal for Measure G Bond Projects, fully complete the District’s prequalification questionnaire, provide all materials requested therein, and be approved by the District to be on the final prequalified contractors list. This prequalification requirement applies to the following contractors:

- A contractor with a B, C-4, C-7, C-8, C-10, C-12, C-15, C-16, C-20, C-34, C-36, C-38, C-39, C-42, C-43, and/or C-46 license(s) that intends to bid as a general contractor (prime contractor) directly to the District.
- A contractor with an A, B, C-4, C-7, C-8, C-10, C-12, C-15, C-16, C-20, C-34, C-36, C-38, C-39, C-42, C-43, and/or C-46 license(s) that intends to bid as a first-tier subcontractor to a general contractor (prime contractor) that is bidding directly to the District.

Contractors must complete this District form; no other prequalification documents submitted by a Contractor will meet the District’s requirements. All contractors shall submit completed questionnaires and an audited or reviewed financial statement for the past two (2) full fiscal years. For current year provide verification of current balances in all related accounts, Profit & Loss Statement.. A letter verifying availability of a line of credit may also be attached; however, it will be considered as supplemental information only, and is not a substitute for the required financial statement as follows:
